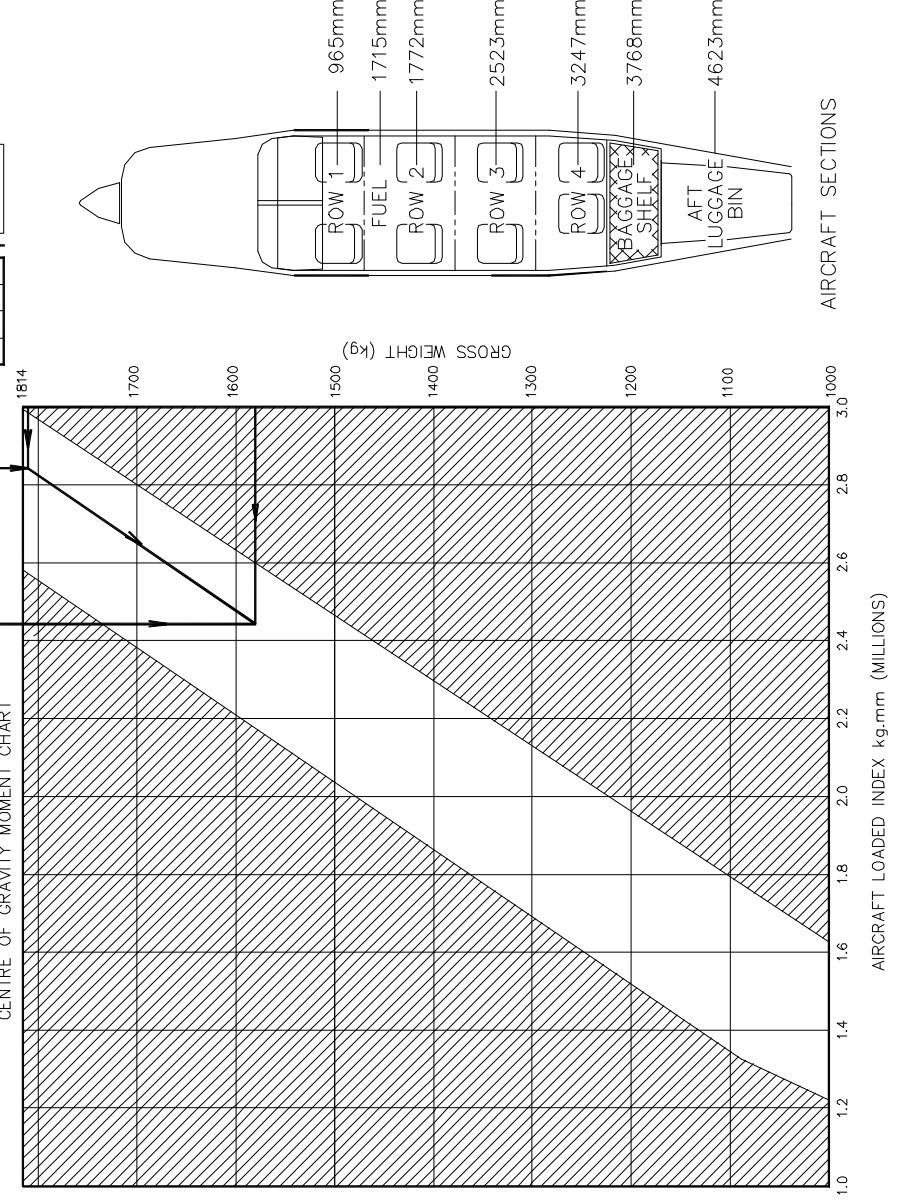
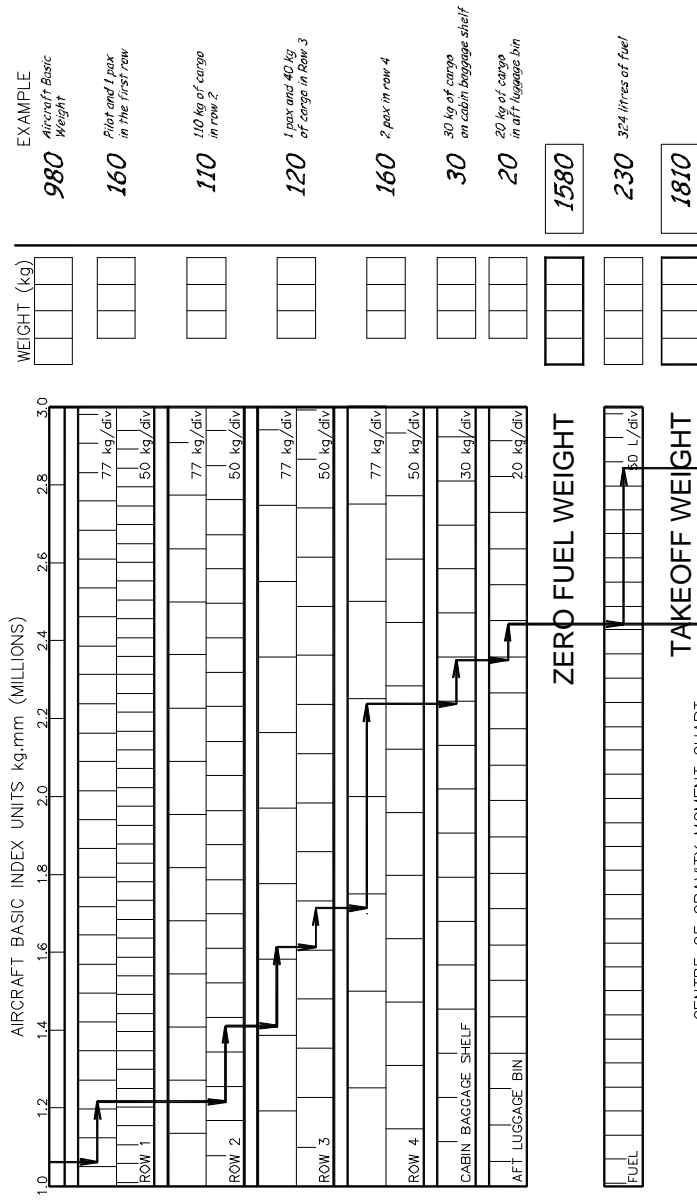


Fig. 6-3a GA8 Loading Trim Sheet

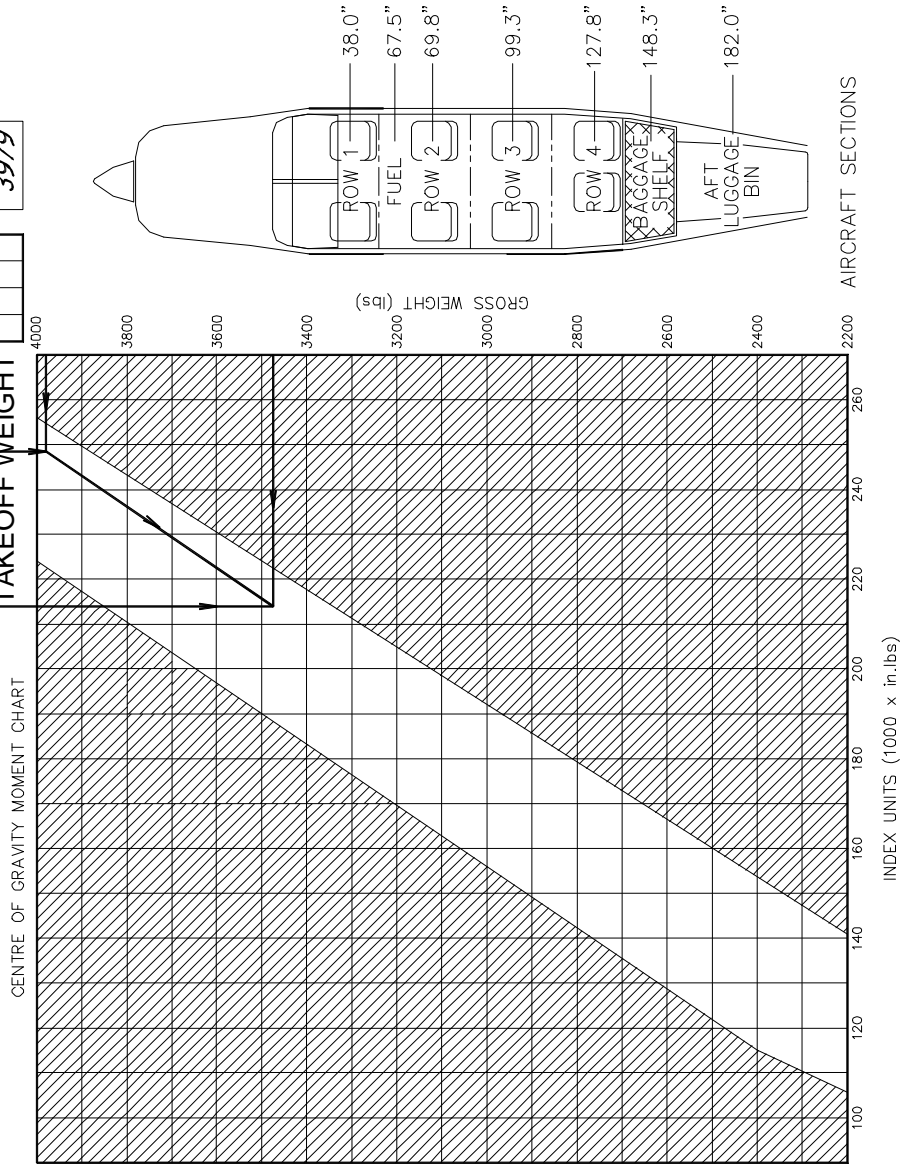
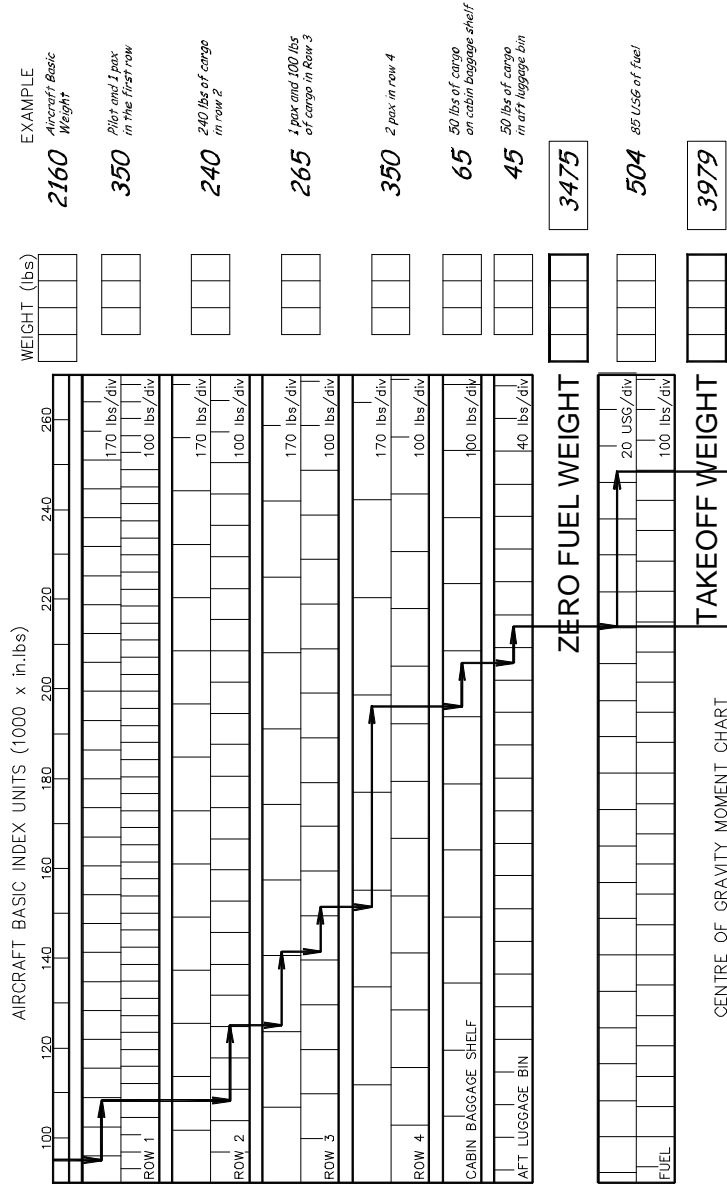


Fig. 6-3b GA8 Loading Trim Sheet
